Variance Request & Building Permit Application, Building Official and Strutz met with applicant regarding project and concerns for placement; construction was approved to begin and variance hearing waived; neighbors were contacted by property owner regarding application.

Harris moved, Engel second to approve variance request and building permit for following, carried:

Discussed and reviewed suggestions to change ordinances relating to variance process and approval. Will have first reading at next regular meeting.

Tree & Branch Disposal, discussed concerns regarding fees and hours for waste disposal site and compost pile. Reviewed current policies and rate analysis for month of June. Harris moved, O'Brien second to approve policy to allow branches to be disposed of free of charge if less than six feet in length, smaller than twelve inches in diameter and does not have any roots, carried.
