Gaming Funds Process Proposal

- 1. Could we treat the gaming funds application process similarly to how we approach the BUMP?
- a. You could have a basic application, different from the current state gaming application. i. You could fund a maximum of 25% of their total raised dollars, not to exceed, a specific threshold, perhaps \$5,000.
- ii. If the concern is total given each year, there could even be an annual cap of giving.
- 2. You'd always have the right to fund more/outside of this if you'd like to make an exception.
- 3. Reasons:
 - a. Gives the nonprofits a better gauge of what you fund and what you don't.
 - b. Establishes a precedent with fair rules for all parties involved
 - c. Forces the nonprofit/group/organization to do some additional fundraising prior to coming to you.
 - d. With proper marketing, it would better ensure the gaming funds get depleted each year
