#### **Engineer Report**:

**2016-1 Lagoon Improvement**, the area was re-seeded the week of July 16<sup>th</sup> and will inspect mid-August. If the grass is not established will negotiate deductive change order and City will take care of grass cover. Engel moved, Conklin second to approve engineering invoice #19029 for \$915.00 for time spent working with contractor on seeding completion, carried-Forward voted no.

**2016-2 Main Lift Station Relocation**, area was re-seeded the week of July 16<sup>th</sup> and will inspect mid-August. If the grass is not established will negotiate deductive change order and City will take care of grass cover. #### **Committee Reports:**

Police, O'Brien moved, Schaefer second to end probationary period for Officers Carson Quam and Dennis Cihak per Chief O'Brien request, carried. Community Center quotes requested for gym roof repair, will have the building committee review once received. Mosquito Spraying has been conducted regularly, at least twice a week, the past month. Chemical has been ordered to continue this schedule. Conklin moved, Forward second to schedule aerial spray, carried. Highway 1 Street Lights, underground wire still need to be fixed by Lau Motors, the contractor has been notified. Airport, construction of new Terminal and Snow Equipment Removal building to begin in September with completion by December 1, 2018.

### Preliminary Budget Hearing:

Discussed 2019 Budget and proposed mill levy changes. Agreed slight increase in mill levy amount for needed improvements to the community center. O'Brien moved, Forward second to approve the 2019 Preliminary Budget as presented, carried.

#### New Business:

**Vacant Lot Sale**, Lot 3 Block 8 McCarthys Addition was advertised for bids in April 2016, no bids were received. Inquiries have recently been made to purchase the lot. The property will be advertised again to receive bids with a request to include intended use of the property with bid amount.

**Clines Addition**, Attorney Paradis reported he was contacted by Dani Dahlstrom regarding concerns of safety on the minimum maintenance road by her property. Paradis recommended the Council looking at a long-term solution to this area.
