Committee Reports: Mayer talked about the SRO grant progress. Bakke explained he had attended the housing study meeting and vacant houses and lots were discussed. Bakke moved, Day second to begin charging all properties a minimum bill of \$50 a month regardless of whether or not they are using services, carried. Discussion clarified that this would include properties that are empty seasonally such as snowbirds and out of state hunter owned homes. Bagley inquired on the status of the kennel that was to be built for stray animals, work has not started on it. She also updated the council on some maintenance and changes that will be happening at the cemetery. Day talked about next steps for the possible street improvement project including the need to evaluate streets now that the snow has melted. Also, mentioned he has been looking at options for a City phone app and thinks it will be much used tool for residents.
