## City Council Meeting October 2, 2023

The City Council met at 6:05 PM at Oakes Community Center with the following members present: Mayor O'Brien, Council: Day, Harris, Mayer and Bagley. <u>Final Budget Hearing:</u> Johnson presented the proposed final budget for 2024 totaling \$480,519.01, an increase of \$40,000 over the 2023 budget. Bagley moved, Day second to approve budget as presented, carried.

<u>Engineer Report</u>: Discussed the next phase of the street improvement project, will meet with committee to get more details on project design and scope. Signed engineering agreement. Discussion about the water treatment plant was tabled to make sure appropriate staff were present.

Minutes, Auditor and Court Report: Day moved, Bagley second to approve minutes, auditor reports and police department report as presented, carried.

<u>Committee Reports</u>: Police Department roof still leaking, will contact roofing contractor to inspect. A request for a stop sign on a residential street led to lengthy discussions about semi-trucks driving in residential neighborhoods and increased education and enforcement of this violation.

<u>Unfinished Business:</u> Bohnenkamp requested the council reconsider his request to connect a new service line for 5 Main Avenue to the Oakes Body Shop service line instead of the main line. Harris moved, Bagley second to allow the connection as requested, with full cost of the hookup being the responsibility of the owner, carried.

New Business: The city received a non-compliance letter after an unannounced inspection of the waste disposal site. Several deficiencies were noted including waste on the ground, paint and chemical containers along with non-burnable items in the burn pile. If these issues continue the site could be closed permanently. Will work on educating residents about best practices and compliance. Clean-up week is typically scheduled in October and after addressing the conditions at the landfill it was decided to have a shortened clean-up time this fall to not expand the current issues. Bagley moved, Mayer second to authorize city auditor to publish petition to vacate alley in Block 4 of Washburn's Addition, carried.
