**Progressive programs also include:

- Property Tax Exemptions: The City of Oakes offers different property tax exemption for commercial use.
- Renaissance Zone: The City of Oakes has an established Renaissance Zone. Property located in this area may qualify for different tax benefits on approved projects.
- OEI works with the city to review and endorse Renaissance Zone applications following all the rules set forth in the designations.

Through their **BUMP program (Building Upkeep and Maintenance Program) the businesses have spruced up their locations. Being aided by this program (which is an ongoing program) Angry Beaver Lodge, Twin Pines Inn, Dr. Brian Dethlefsen Chiropractic, Village Mall, Sweets 'N Stories, Ptacek Financial, Oakes Drug, R & R, JJLC-LLC, Ron's heating and Appliance, the Loft, Hill's, Quilt and Sew, Total Home, Oakes Family Pharmacy, Computer Express, 502 Flair, Domine Sales, Shadow Lanes, Back to Health, Moving Mountains, Tornado Stop, Tiny Tornadoes. Close to \$90,000 has been disbursed through this program.

**In the past 20 years, OEI has been able to grant to non-profits through their charitable gaming. Over half a million has been awarded. **OEI has been involved with City Beautification: Flowerpots, Walking Path, Pole Banners, Garland, and the like.

**OEI has conducted studies in Wind Energy, Labor and Housing Surveys.

**OEI and the City of Oakes offer a range of programs to assist businesses to cost-effectively locate and expand their operations within our community. These programs are designed to aid in the form of tax incentives, business financing, infrastructure development, employee recruitment and training and general assistance.

**In addition, a network of economic development assistance organizations, staffed by experienced professionals at the state and regional level are ready to utilize all available resources to confidently

develop a comprehensive incentive proposal that will enable a business to locate and operate its facility in Oakes.

**Oakes took the lead and held meetings traveling to communities in southeast North Dakota, crossing the border to reach into South Dakota to work together. Board members realized that if the area thrives – so will all the communities. As a result, Dakota State Line Regional Alliance was founded and continues to this day. The organization is mainly used to channel funds as a 501 © 3. Oakes maintains the funds and acts throughout the region.

**OEI filed mountains of paperwork to become and Empowerment Zone which would qualify Oakes for government funds and, as a result, was named a Champion Community.

**For COVID-19 Relief, 36 Oakes businesses were assisted with the total grant amount exceeding \$51,000.

**OEI is dedicated to students. If you remember the "McCarthy" project – a house was built by the students in the construction classes at the vocational school. Funding from OEI made this project possible. OEI also grants funds to the Southeast Region Career and Technology Center making it easier for students to attend National competitions.

**A newly developing program is scholarship assistance for businesses to send applicants to train and then return to provide learned skill sets to the business that employs them.
